

**KRLD “Dallas Symphony Orchestra ’08-’09 Pops Giveaways”**  
**Official Contest Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

**1. How to Enter the Contest**

- a. The KRLD “Dallas Symphony Orchestra ’08-’09 Pops Giveaways” contest will begin on Monday, May 5, 2008, at approximately 12:01 a.m. Central Time (“CT”) and end on Monday, May 19, 2008, at approximately 10:00 a.m. CT.
- b. To participate in the contest, listeners must visit [www.krld.com](http://www.krld.com) and click on the Dallas Symphony contest item. Listeners must then complete the registration form with their first and last name, complete address, city, state, zip code, date of birth, daytime phone number and email address. Only one (1) Internet entry per person and one (1) Internet entry per email address are permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address. All entries must be received by May 18, 2008, at 11:59 p.m. CT. For purposes of these Official Rules, "receipt" of any online entry will be solely determined when the contest Administrator's website server records the entry data. Any automated computer form reply or receipt (such as one confirming delivery of email) does not constitute actual receipt by Administrator of an entry form for purposes of these Official Rules. KRLD is not responsible for entries not received due to difficulty accessing the Internet, service outage or delays, computer difficulties or other technological glitches.
- c. Limit one (1) entry per person, per household, per email address.

**2. Eligibility Restrictions**

- a. The contest is open to all KRLD listeners who are 18 years of age or older and legally reside in the Dallas/Fort Worth metropolitan area. Employees of KRLD, its licensee, its corporate parents, subsidiaries and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Dallas/Fort Worth metropolitan area and the members of their immediate families are ineligible to participate or win.
- b. Listeners are eligible to win a KRLD contest only once every sixty (60) days and a prize valued at \$600.00 or more only once every six (6) months. Only one (1) winner per household is permitted in any contest.
- c. Winners and their guests must sign a release prior to the acceptance of any prize.
- d. Participants are required to provide truthful information and KRLD will reject and delete any entry it discovers to be false or fraudulent. KRLD will also disqualify and delete any entry received from persons under the minimum age specified for this contest and will also delete the entries received from any person under the age of 13 in compliance with the Children’s Online Privacy Protection Act.

### **3. Prizes**

- a. Five (5) Grand Prize winners will each receive one (1) voucher good for two (2) tickets to a 2008-2009 Dallas Symphony Orchestra Pops concert, valid beginning August of 2008 and expiring May 16, 2008, and one (1) audio CD of a 2008-2009 Dallas Symphony Orchestra Pops performer. Artist to be determined by sponsor. Approximate Retail Value ("ARV") of prize is \$140.00.
- b. All prizes or prize certificates may be picked up at the office of KRLD, 4131 North Central Expressway, Ste. 500, Dallas, TX 75204. The winner will forfeit any prize or prize certificate not claimed within forty five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. Winner will be subject to the terms and conditions of the provider of the prize certificate, including expiration dates. KRLD is not responsible for the safe arrival of a prize or prize certificate.
- c. Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. Prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

### **4. Selection of Winners**

- a. Decisions of KRLD management with respect to the contest are final.
- b. Five (5) winners will be chosen on Monday, May 19, 2008, at approximately 10:00 a.m. CT in a random drawing from all eligible entries received by the registration deadline. Winners will be notified by phone. If a winner cannot be reached by phone within three (3) working days, the prize will be forfeited and an alternate winner will be selected by random drawing from remaining eligible entries.
- c. Odds of winning depend upon the number of eligible entries received.
- d. Winner(s) need not listen or be present to win.
- e. Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within one (1) day of notification attempt or prize will be forfeited and an alternate winner may be chosen by random drawing from the remaining eligible entries.

### **5. Conditions**

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the contest, the winners and their guests agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- c. Prior to awarding any prizes, KRLD, solely at its discretion, may require contest winners (and their guests) to sign a liability release agreeing to hold KRLD, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- d. KRLD, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the KRLD Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. KRLD reserves the right to make changes in the rules of the contest, including the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of KRLD, any events associated with the prize are delayed, rescheduled, postponed or cancelled, KRLD reserves the right, but not the obligation, to cancel or modify the contest and shall not be required to award a substitute prize.
- f. Failure to comply with the contest rules may result in a contestant's disqualification solely at the discretion of KRLD.
- g. KRLD is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcement of a prize.
